Pursuant to the decision of the High Power Committee taken in its meeting held on dtd. 02-05-2025 communicated vide Govt. in the Department of School & Mass Education Letter No. 14431/SME, Dt. 27-05-2025 and as per the guidelines issued by the Government in the Department of School & Mass Education, Odisha, Bhubaneswar vide Resolution No. 30720/SME dtd. 23.09.96 read with G.O No. 29519/SME dtd. 26.9.1998 No Objection Certificate (NOC) is hereby granted in favour of Hind Zinc Vidyalaya, Zinc Nagar, Lephripara, Sundergarh - 770072 to upgrade / run Self Financed High School with Class- IX & X which is to be affiliated to CBSE subject to following terms and conditions.

1. The No Objection Certificate now issued shall be subject to the terms & conditions as prescribed in G.O No. 30720/SME dtd. 23.09.96 and No. 29519/SME dtd. 26.09.1998 read with G.O No. 10011/SME dtd. 11.06.2004. Any relaxation extended this year shall be fulfilled within one year.
2. The school shall be opened to inspection by the Officers of S & ME Deptt. as and when required.
3. No Financial Assistance or any kind of Grant-in-Aid (either recurring or non-recurring) will be claimed by the institution from the Government at any point of time.
4. The High Power Committee shall be competent to review the NOC now granted to the institution concerned and shall be competent to withdraw the same on violation of terms and conditions laid down in Govt. Acts / Rules / Executive Instructions.
5. The Managing Committee shall be constituted in accordance with the Sec-7 of the Odisha Education Act-1969 as amended from time to time.
6. The school shall not be shifted from its present location without prior approval of Director, Secondary Education, Odisha.

In pursuance of the decision of the High Power Committee in its meeting held on 17.11.07 copy communicated vide Govt. Memo No.23362/SME dt-27.11.07 and as per the guidelines issued by the Govt. in the Department of School & Mass Education, Orissa, Bhubaneswar vide Resolution No.30720/ SME, Dt.23.09.06. No Objection certificate is granted in favour of Hindzinc Vidyalaya, Zinc Nagar, Sundargarh to open an un-aided Primary School upto Class-VII for the purpose of obtaining affiliation from the ICSE/ CBSE subject to the following terms and conditions.

1. The "No Objection Certificate" now issued shall be subject to the terms and conditions as prescribed in the G.O. No.30720/SME, Dt- 23.09.96.
2. The Land is to be recorded in the name of institution and copy of the record of the rights to be furnished by the authority of the institutions within one year from the date of issue of the order failing which NOC will be automatically lapsed.
3. Medium of instruction in the School shall be English but Oriya shall be taught as a subject to all pupils in the institution compulsory.
4. The school shall be open for inspection by the Inspection team.
5. No financial assistance and grant-in-aid (both recurring and Non-recurring) will be claimed by the institution from the Govt. at any point of time for meeting the salary cost and its component towards teaching and Non-teaching staff appointed by the managing committee.
6. The M.C. of School will not shift the present location of the school without prior approval of Director, Elementary Education, Orissa.
7. The High Power Committee shall review the N.O.C. granted to the institution concerned and shall withdraw the same if the terms and conditions contained in the G.O No.30720/ SME, Dt.23.09.96 is violated at any time.
8. The Managing Committee shall be constituted in accordance with the Section & of the Orissa, Education Act, 1969.

Pursuant to the decision of the High Power Committee in its meeting held & communicated vide Govt. letter No. 10077/SME, dtd. 27.06.2009, and as per the guideline issued by the Government in the Department of School & Mass Education, Orissa, Bhubaneswar vide Resolution No. 30720/SME, dtd. 23.9.1996. No objection certificate is granted conditionally for three years only in favour of following English Medium Schools for opening an un-aided Secondary Schools up to Class-X for the purpose of obtaining affiliation from the CBSE/ICSE subject to the following terms and conditions:

1. The "No Objection Certificate" now issued shall be subject to the terms and condition as prescribed in the G.O. No. 30720-SME, dtd. 23.9.1996
2. The Land is to be recorded in the name of institution and copy of the record of the rights to be furnished by the authority of the institutions within one year from the date of issue of the order.
3. Own building of the school should be completed as per the norms on its own land within one year.
4. Medium of instruction in the School shall be English but Oriya shall be taught as a subject to all pupils in the institution compulsory.
5. The school shall be open for inspection by the Inspection team.
6. No financial assistance and grant-in-aid (both recurring and Non-recurring) will be claimed by the institution from the Govt. at any point of time for meeting the salary cost and its component towards teaching and Non-teaching staff appointed by the managing committee.
7. The M.C of School will not shift the present location of the school without prior approval of Director Secondary Education, Orissa.
8. The High Power committee shall review the N.O.C granted to the institution concerned in the next HPC after elapse of one year and shall withdraw the same if the terms and conditions contained in the G.O. No-30720/SME, dtd. 23.9.96 is violated at any time.
9. The Managing Committee shall be constituted in accordance with the Section-7 of the Orissa, Education Act-1969.


